Please note that we do not accept any responsibility for any losses or expenses, which you or any member of your party may incur as a result of failing to secure adequate coverage

**MEDICAL CONDITION:** ITC is not responsible for any medical conditions that may occur during or prior to the tour.  
**CANCELLATION:** All cancellations must be in writing to us and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are received by us. No refunds are issued for cancellations received after the date the tour departs. Penalties will apply. If you cancel your tour, cancellation fees and penalties will be deducted from your refund or deposit. If the tour services as indicated by the itinerary cannot be supplied or there are changes in the itinerary for reasons beyond the control of ITC, we will arrange for provision of comparable services.
