CANCELLATION: All cancellations must be in writing to us and must be signed by the person who made the original reservation. Cancellations are only effective from the day they are received by us. No refunds are issued for cancellations received after the date the tour departs. Penalties will apply. If you cancel your tour, cancellation fees and penalties will be deducted from your refund or deposit. Cancellation fees will apply to all deposit checks (Airline penalties could be equal to the total cost of the ticket.) Cancellation fees apply to each person. Deposit is not refundable.

ITC assumes no responsibility or liability in connection with the service of an aircraft, motor coach, taxi, or other conveyances, which may be used in the performance of its duty to the passengers. All vouchers and other documents for services issued by the company are subject to the terms and conditions specified by the suppliers and to the laws of the country where services are supplied. If the tour services as indicated by the itinerary cannot be supplied or there are changes in the itinerary for reasons beyond the control of ITC, we will arrange for provision of comparable services. ITC reserves the right to make changes in the itinerary whenever ITC deems it necessary to the comfort, convenience and safety of the participant at any time.
